Background information on Town of Conesus Bicentennial: A town was formed at this location in 1819 or 1820 – here are varying accounts. It was named Freeport. In 1825, the name was briefly changed to Bowersville. In April of 1825, the name was officially changed to Conesus, thus marking April 2025 to be 200 years as The Town of Conesus. It is believed that the name comes from the Seneca Indian name of Ga-ne-a-sos, which has multiple translations: "Home of the Nanny Berries" and "Forever Beautiful".
