LIVINGSTON COUNTY UPDATES

Supervisor Wester updated us on the following:

The county is in the middle of budget process. Ian Coyle has returned as a consultant to help with the county budget. Livingston County Watershed Council meets next week. There are a lot of people complaining about the lake levels, but it's Mother Nature. Don went to the Conesus Lake Association Annual Meeting and really learned a lot. With the drought and weather we have been having, we are losing 9 million gallons of water a day through evaporation. Temperature, precipitation, etc. of course play a role. Supervisor Wester and Councilman Fama have both been around the lake all their lives and they do not recall the lake being this low before.

RICKY GREENE PARK UPDATE

Councilman Butterbrodt updated us on the following:

Councilman Butterbrodt met with Holley Construction and planned out where the sidewalk will go. Work will likely begin on Monday. We will likely need to replace a toilet in the men's room in the spring. The water is now shut off at the park until the spring. We will check the cabin roof again and double check if it needs replacing soon or not. There is no evidence that it is leaking.

HIGHWAY BARN PROJECT UPDATE

The contractors, Thompson Builds, say that they are done. Our engineer will look and confirm that the work is complete as it should be. Jeff Wilson has been our engineer for this project, and he has done an outstanding job throughout the process and has had great communication.

LOCAL LAW NO. 1-2025 TO OVERRIDE THE TAX LEVY LIMIT FOR THE FISCAL YEAR 2026

BE IT ENACTED, by the Conesus Town Board, Town of Conesus, Livingston County, State of New York, as follows:

Section I. Authorization

This local law is adopted pursuant to General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the tax levy limit for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

Section II. Title and Purpose

This law shall be known as and may be cited as Local Law No. ______-2025 to Override the Tax Levy Limit for the Fiscal Year 2026. The purpose of this Local Law is to override the tax levy limit established at New York General Municipal Law Section 3-C for the fiscal year 2026.

Section III. Legislative Finding

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Conesus, pursuant to General Municipal Law §3-c, and to allow the Town of Conesus to adopt a budget for the fiscal year 2026 that requires a real

property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c. The Town Board finds such override will allow the Town to continue to effectively manage

and maintain the health of the finances of the Town.

Section IV. Tax Levy Limit Override

The Town Board of the Town of Conesus, County of Livingston, is hereby authorized to adopt a budget for the fiscal year 2026 that requires a tax levy that is greater than the tax

levy limit otherwise prescribed by General Municipal Law Section 3-c.

Section V. Validity and Severability

Should any word, section, clause, paragraph, sentence, part or provision of this Local Law be declared invalid by a Court of competent jurisdiction, such determination shall not

affect the validity of any other part hereof.

Section VI. Repeal, Amendment and Supersession of Other Laws

All other Ordinances or Local Laws of the Town of Conesus which are in conflict with the provisions of this Local Law are hereby superseded or repealed to the extent necessary to

give this Local Law force and effect during its effective period.

Section VII. Effective Date

This Local Law, after its adoption by the Town Board of the Town of Conesus, shall take effect immediately upon its filing with the Office of the Secretary of State of the State of New York.

Supervisor Wester shared an experience of a resident on Rowland Rd. as well as his own recent experience where Rowland Rd. meets Rte. 15. It is very difficult to see when turning from Rowland Rd. onto Rte. 15. He shared this with the Livingston County Traffic Safety Board as well. Highway Superintendent Marusiak shared how difficult it is to pull out there with the plow truck, dump the snow, and then back up again (Rowland Rd. is a town road, Rte. 15 is a state road).
